RESOLUTION FOR AUGMENTATION OF FUND FOR THE PAYMENT OF ADDITIONAL BENEFIT/EXTRA CASH GIFT OF THE MUNICIPAL OFFICIALS AND EMPLOYEES, LGU-TIGBAUAN PER LOCAL BUDGET MEMORANDUM NO. 58 DATED DECEMBER 11, 2008 OF THE DEPARTMENT OF BUDGET AND MANAGEMENT.

WHEREAS, Local Budget Memorandum No. 58 dated December 11, 2008 authorized the grant of extra cash gift/additional benefit to officials and employees of LGUs for fiscal year 2008;

WHEREAS, anent thereto, the Municipal Mayor, Honorable James Excelsior M. Torres, thru his 1st Indorsement to the Hon. Sangguniang Bayan, had requested for the passing of a resolution for the augmentation of funds for the payment of additional benefits/EXTRA Cash Gift to Municipal Officials and Employees for CY 2008 per Local Budget Memorandum No. 58 dated December 11, 2008 of the Department of Budget and Management chargeable against the Personal Services Savings for CY 2008 of the different Offices of the Local Government Unit of Tigbauan, Iloilo;

WHEREAS, the Members of the Local Finance Committee issued a certification that the amount of Two Million One Hundred Eighty Seven Thousand Two Hundred Sixty Four Pesos (P2,187,264.00) representing savings on the Personal Services for CY 2008 is available for payment of Extra Cash Gift of Municipal Officials and Employees of the Local Government Unit of Tigbauan, Iloilo per DBM Local Budget Memorandum (LBM) No. 58 dated December 11, 2008 chargeable against the CY 2008 Personal Services Savings.
