RESOLUTION FOR AUGMENTATION OF FUND FOR THE PAYMENT OF ADDITIONAL BENEFIT/CASH GIFT IN THE AMOUNT OF ONE MILLION THREE HUNDRED SEVENTY THOUSAND SEVEN HUNDRED FIFTY TWO PESOS (P1,370,752.00) FOR PERMANENT EMPLOYEES AND ELECTIVE OFFICIALS OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN TOTALLING 128 AT TEN THOUSAND SEVEN HUNDRED NINE PESOS (P10,709.00) EACH CHARGEABLE AGAINST THE PERSONAL SERVICES SAVINGS –CY 2008
