Resolution No. 2009-002

RESOLUTION CONFORMING, APPROVING AND ADOPTING MUNICIPAL DEVELOPMENT COUNCIL RES. NO. 2008-001 - RESOLUTION RECOMMENDING APPROVAL OF THE PRIORITIZED SOCIO-ECONOMIC DEVELOPMENT PROJECTS FROM THE CY 2009 20% INTERNAL REVENUE ALLOTMENT (IRA) FUND OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipal Development Council of the Municipality of Tigbauan held a meeting on October 13, 2008, 2:30 in the afternoon at the Tigbauan Covered Court to discuss the 20% Development Fund for the CY 2009. The Municipal IRA for CY 2009 is P53,359,577.00 and the Mandatory 20% IRA Development Fund for CY 2009 is P10,671,915.40. After a thorough deliberation and review of the prioritized projects, the Municipal Development Council unanimously approved the allocation of the 20% IRA Fund of the Local Government Unit of Tigbauan for the year 2009. The itemized projects and programs are enumerated in the Resolution of the Municipal Development Council hereto attached as Annex "A";

WHEREAS, the Office of the Municipal Mayor forwarded the Annual 20% Development Plan for CY 2009 to the Office of the S.B. on November 13, 2008;

WHEREAS, during the Municipal Development Council meeting it was discussed that the budget allocation of P400,000.00 for Saludan Festival, P10,000.00 for Namocon Ambush and P20,000.00 for Rehabilitation of Parara Landmark (totalling P430,000.00) will be taken from the **Preservation of Cultures and Historical Sites Budget** under *ECONOMIC SERVICES SECTOR*;

WHEREAS, the **Community Development Assistance Program (CDAP)** in the amount of P1,066,248.40 under *ECONOMIC SERVICES SECTOR* includes the Project Allocation of Vice Mayor, SB Members, SKMF President and Liga ng mga Barangay President for their respective proposed programs and projects;

WHEREAS, the review of the foregoing Resolution of the Municipal Development Council embodying the 20% Development Projects for the year 2009 , shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, a Committee Report No. 2009-002 was adopted on January 14, 2009 and all the Findings will form part of this Resolution;

WHEREAS, the appropriation for the 20% Development Fund shall be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the 20% development fund shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government units;
