Resolution No. 2009-003

RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM SENATOR MAR ROXAS, HOUSE OF SENATE, MANILA, IN THE AMOUNT OF FIVE MILLION PESOS (P5,000,000.00) FOR THE REPAIR AND REHABILITATION OF THE TIGBAUAN PUBLIC MARKET, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan is a component town of the Province of Iloilo with 52 barangays, having a population of 59,156 inhabitants as of 2007 (*actual survey*) and with 35,327 registered voters as of December 19, 2008;

WHEREAS, the Municipality of Tigbauan has a rapid expanding population and it badly needs an improved and spacious market for its populace;

WHEREAS, the Tigbauan Public Market was constructed way back in 1950s yet and is now very dilapidated resulting to leaking of roofs, torn or broken walls, very poor ventilation and lighting, poor drainage system and inadequate water supply;

WHEREAS, the Sangguniang Bayan of Tigbauan in its desire to undertake the major repair and rehabilitation of the Tigbauan Public Market, also requested financial assistance from the Hon. Senator Mar Roxas last June 8, 2005 (*thru the herein attached S.B. Resolution No. 2005-052*) but this was not given appropriate action;

WHEREAS, because of its very dilapidated and dangerous condition, the Municipal Government of Tigbauan finally decided to start the urgent repair and rehabilitation of this public market last December 23, 2008 out of its very limited resources and insufficient amount loaned from the Development Bank of the Philippines (DBP);

WHEREAS, the people of Tigbauan, through the Municipal Officials put their hopes on Senator Mar Roxas for the realization of our Public Market specially the completion of its center structure;

NOW, THEREFORE, on motion of Hon. Elmer Torrato, Vice Chairman, S.B. Committee on Market and Slaughterhouse and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Agaton Tumabotabo, Hon. Norberto Turalba, Hon. Loreta Lungay-Arias, Hon. Elmer Torrato, Hon. Orvillo Tangente and Hon. Lea Torreflores,

RESOLVED, AS IT IS HEREBY RESOLVED, to request Financial Assistance From Senator Mar Roxas, House Of Senate, Manila, In The Amount Of Five Million Pesos (P5,000,000.00) For The Repair And Rehabilitation Of The Tigbauan Public Market, Municipality Of Tigbauan, Province Of Iloilo,

RESOLVED FURTHER, to forward a copy of this Resolution to Senator Mar Roxas, House of Senate, Manila, for his information and/or appropriate action and to Hon. Mayor James Excelsior M. Torres for his information.
