RESOLUTION PROVIDING FINANCIAL ASSISTANCE FOR THE CONSTRUCTION OF THE SENIOR CITIZEN AND GENDER DEVELOPMENT CENTER IN THE TOTAL AMOUNT OF SEVENTY THOUSAND PESOS (P70,000.00) - P20,000.00 FROM VICE MAYOR ROEL T. JARINA, P5,000.00 EACH FROM THE SB MEMBERS INCLUDING THE LIGA PRESIDENT AND THE SKMF PRESIDENT CHARGEABLE AGAINST COMMUNITY DEVELOPMENT ASSISTANCE PROGRAM (CDAP), 2009 - 20% DEVELOPMENT FUND OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, THE Senior Citizen Association has started the First Phase for the Construction of the Senior Citizen & Gender Development Center, Tigbauan, Chapter last January 7, 2009. However due to Budgetary Constraint and high cost of construction materials, completion of such project was interrupted;

WHEREAS, under the Community Development Assistance Program (CDAP), 2009 - 20% Development Fund, there is an available fund for the financial assistance for projects incidental to the development of the services for our constituents;

WHEREAS, the Municipal Mayor has approved that financial assistance be extended for the construction of Senior Citizen and Gender Development Center In The Total Amount Of Seventy Thousand Pesos (P70,000.00) - P20,000.00 From Vice Mayor Roel T. Jarina, P5,000.00 Each From The SB Members Including The Liga President And The SKMF President Chargeable Against Community Development Assistance Program (CDAP), 2009 20% Development Fund;
