RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-01-09-236 OF EVELYN ET-AL WITH TCT NO. F451768, LOT NO. 3148 WITH A TOTAL AREA OF 6,959 SQUARE METERS MORE OR LESS, CONTAINING FIVE (5) LOTS LOCATED AT BARANGAY PARARA NORTE, TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application No. SA-01-09-236 located at Barangay Parara Norte, Tigbauan, Iloilo and its supporting documents of EVELYN TUPAN ET-AL was submitted to the Office of the Evaluation Officer on January 8, 2009 for evaluation;

WHEREAS, after evaluation, the said Subdivision Application and its supporting documents were forwarded to the Office of the Sangguniang Bayan last January 8, 2009 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, TCT No. F-45168, Lot No. 3148 with Five (5) lots has a total land area of 6,959 square meters more or less;

WHEREAS, the purpose/intent of this application is to subdivide among heirs/co-owners;

WHEREAS, the conditions of said approval shall be the following:

- a.) In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;
- b.) Comply with all the corrections as indicated on the plan;

- c.) Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.

BE IT RESOLVED, AS THIS SANGGUNIANG BAYAN HEREBY RESOLVED, to approve the Subdivision Application No. SA-01-09-236 of EVELYN TUPAN ET-AL With TCT No. F-45168, Lot No. 3148 With A Total Area Of 6,959 Square Meters More Or Less, Containing Five (5) Lots Located At Brgy. Parara Norte, Tigbauan, Iloilo,
