WHEREAS, as provided for by Republic Act No. 6975, Sec. 43, that the Sangguniang Panglunsod/Bayan in every city and municipality shall create such number of People's Law Enforcement Board (PLEB), The PLEB shall have jurisdiction to hear and decide citizens' complaints or cases files before it against erring officers and members of the PNP;

WHEREAS, there is a need to reorganize the composition of the PLEB to foster efficient and effective public service;

WHEREAS, the PLEB shall be composed of the following:
