RESOLUTION CONFORMING AND APPROVING THE CY 2009 BARANGAY ANNUAL
BUDGETS AND 20% DEVELOPMENT PLANS OF BARANGAYS: BARROC, #4
(POBLACION), SUPA, DORONG-AN, BUGASONGAN, BUENAVISTA AND PARARA
SUR, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipal Budget Officer on March 25, 2009 endorsed to this
Office the Barangay Annual Budgets and Development Plans for CY 2009 of
Barangays: Barroc, #4 (Poblacion), Supa, Dorong-an, Bugasongan, Buenavista and
Parara Sur, this municipality;

WHEREAS, the Review of the foregoing Appropriation Ordinance embodying the
Annual Budgets and 20% Development Plans for CY 2009 of Barangays: Barroc, #4
(Poblacion), Supa, Dorong-an, Bugasongan, Buenavista and Parara Sur, shows
apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art.
454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of
President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum
Circular No. 1, Series of 2005 of the DILG and DBM issued on September 30, 2005;

DILG and DBM issued on September 30, 2005;
