RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HON. NASSER C. PANGANDAMAN, SECRETARY OF THE DEPARTMENT OF AGRARIAN REFORM (DAR) IN THE AMOUNT OF TEN MILLION PESOS (P10,000,000.00) FOR THE IMPROVEMENT OF FARM-TO-MARKET ROADS IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO
