RESOLUTION ASKING FINANCIAL ASSISTANCE IN THE AMOUNT OF TEN MILLION PESOS (P10,000,000.00) FROM HON. NASSER C. PANGANDAMAN, SECRETARY OF THE DEPARTMENT OF AGRARIAN REFORM (DAR) FOR THE REHABILITATION OF THE FOLLOWING FARM-TO-MARKET ROADS: BRGY. NAPNAPAN SUR-BITAS-BAGUMBAYAN RD.; BRGY. BAGACAY-DANAO, BAGACAY-CANSILAYAN RD.; BRGY. BUYU-AN-CANSILAYAN RD.; BRGY. CANSILAYAN-SUPA RD.; BRGY. SERMON RD.; BRGY. BUENAVISTA-LANAG RD.; AND BRGY. BAROSONG-CANABUAN-ISIAN RD., ALL IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan is an agricultural municipality;

WHEREAS, twenty five percent (25%) of its agricultural area is irrigated rice land but most of it is devoted to upland agriculture conducive to high value crops;

WHEREAS, the farm-to-market road is necessary in order to bring the produced crops to the market in a more accessible way;
