RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE BUREAU OF FIRE PROTECTION (BFP), REGION VI, TO SAFEGUARD THE SUPPLIES AND EQUIPMENTS PURCHASED BY THE MUNICIPALITY OF TIGBAUAN

WHEREAS, as provided for under the Local Government Code, the Sangguniang Bayan shall enact measures to ensure the safety and protection of all municipal government property and to prescribe reasonable limits and restraints on the use of property within the jurisdiction of the municipality;

WHEREAS, the Municipality of Tigbauan has purchased the following supplies and equipments for the use of the Bureau of Fire Protection, Tigbauan Station:

- a. 1 Unit Shotgun (Norinco SN 0038173)
- b. 3 units 9mm Pistol (SAM SN T911061154, T911061155 and T911061156)
- c. 2 units handset radio (Motorola SN 246XJQ3944 and 246XJQ3930)
- d. 1 unit 5 KVA Generator Set (Coleman Powermate SN F23600463B)

WHEREAS, it is imperative that the Local Government Unit shall ensure the safety and protection of all municipal government property and the use of such property shall be regulated;

WHEREAS, there is a need for Municipal Mayor James Excelsior M. Torres to enter into a memorandum of agreement, in behalf of the Municipality of Tigbauan, with the Bureau of Fire Protection, Region VI and Tigbauan Station to set forth the terms

and conditions on the use of the above mentioned properties purchased by the Municipality of Tigbauan
