WHEREAS, the recitation of the COUNCILOR’S CREED is included under item IV of the “**Calendar/Order of Business of the Regular Session of the Honorable Sangguniang Bayan, Tigbauan**”, Iloilo;

WHEREAS, since it is a Councilor’s Creed and that the Vice Mayor is not a Councilor, the latter opts to refrain in joining with his colleagues in reciting the creed;
