RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HON. GILBERT TEODORO, SECRETARY OF NATIONAL DEFENSE AND CHAIRMAN, NATIONAL DISASTER COORDINATING COUNCIL, IN THE AMOUNT OF TWENTY MILLION PESOS (P20,000,000.00) FOR THE REPAIR AND REHABILITATION OF SIBALOM RIVERBANK DIKE WHICH WAS DESTROYED DURING TYPHOON “FRANK” LOCATED ALONG BARANGAYS 2 & 3 (POBLACION), MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Municipality of Tigbauan was ravaged by typhoon “FRANK” from June 20 to 22, 2008 and caused tremendous damage to the lives and properties of the people of this municipality;

WHEREAS, infrastructure and other government facilities such as hanging bridges, municipal and barangay roads and bridges, school buildings, river dikes and ripraps, and other government structures were damaged by typhoon “Frank” to which the amount appropriated for 2008 5% calamity fund was not enough to rehabilitate the said structure;

WHEREAS, there is an urgent need for financial assistance to LGUs in order to repair and/or rehabilitate the Sibalom Riverbank Dike Located along Barangays 2 & 3 (Poblacion), Municipality of Tigbauan, Province of Iloilo to protect the whole poblacion and neighboring barangays from the dangers of flood waters;
