RESOLUTION EARNESTLY APPEALING TO THE 1ST ENGINEERING DISTRICT (DPWH), REGION VI, ILOILO CITY, FOR THE REPAIR AND MAINTENANCE OF THE TIGBAUAN-CORDOVA-LEON ROAD SPECIFICALLY FROM THE INTERSECTION OF TUPAS AND TUPAN STREETS TO TIGBAUAN NATIONAL HIGH SCHOOL, TIGBAUAN, ILOILO

WHEREAS, the Sangguniang Bayan, during its previous sessions dated October 30, 2006 and July 2, 2008 had passed resolutions relative to the repair and maintenance of the Tigbauan-Cordova-Leon Road specifically from the intersection of Tupas and Tupan Streets to Tigbauan National High School;

WHEREAS, in response to the aforesaid resolutions, the aforementioned road with an estimated length of .75 km. was repaired thru surfacing/asphalt overlay;

WHEREAS, the said road is a busy road especially during school days considering the big population of high school students studying at the Tigbauan National High School;

WHEREAS, the occurrence of heavy rains brought about by the bad weather again caused damage to the abovementioned road thus immediate repair and maintenance thereof is very necessary for the safety and convenience of the riding public especially the commuters consisting of teachers, students, public/private employees, among others;

WHEREAS, it had been noted that the last repair and maintenance of the road cited above was done sometime in July 2008 as per attached related documents and pictures of action taken by the Iloilo 1st District Engineering Office;
