RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR JAMES EXCELSIOR M. TORRES TO NEGOTIATE AND ENTER A LOAN AGREEMENT WITH DEVELOPMENT BANK OF THE PHILIPPINES FOR THE IMPROVEMENT AND EXPANSION OF TIGBAUAN LEVEL III MUNICIPAL WATER SYSTEM AND TO HIRE A CONSULTANT THAT WILL ASSIST THE LGU IN PREPARING THE FEASIBILITY STUDY, DETAILED ENGINEERING DESIGN AND OTHER TECHNICAL REQUIREMENTS FOR THE APPROVAL OF THE LOAN

WHEREAS, the Municipality of Tigbauan has various sources of water for domestic use, but has no efficient waterworks system that can supply potable water to its residents, businesses and constituents;

WHEREAS, the establishment of a municipal waterworks system is one of the priority projects of the municipal government that will improve its existing water supply and respond to the needs of the people;

WHEREAS, the existing development funds of the municipal government is not sufficient to finance the establishment of the proposed municipal waterworks system;

NOW, THEREFORE, on motion of HON. MARLON R. TERUÑEZ, Chairman, Committee on Infrastructure and General Services and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Norberto T. Turalba, Hon. Jose T. Tavarro, Jr., Hon. Loreta Lungay-Arias, Hon. Elmer T. Torrato and Hon. Orvillo T. Tangente,

RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Bayan of the Municipality of Tigbauan to request, negotiate and enter into a Loan Agreement with the Development Bank of the Philippines (DBP) subject to the ratification of the Loan

Agreement and other supporting documents, all laws and existing legal rules and regulations,

RESOLVED FURTHER, to Authorize The Municipal Mayor, Hon. James Excelsior M. Torres To Hire A Consultant Who Will Assist The Municipal Government In Complying With The Loan Requirements Such As The Feasibility Study, Detailed Engineering Design And Other Technical Requirements Of The Bank,

RESOLVED FINALLY, to furnish copies of this Resolution to the Development Bank of the Philippines (DBP), Hon. Mayor James Excelsior M. Torres, the Municipal Treasurer and to all concerned agencies for their information, guidance and reference,
