**Resolution No. 2009-057**

RESOLUTION INTERPOSING NO OBJECTION/OPPOSITION (IN LINE WITH THE DENR'S PRIORITY PROGRAM FOR CY 2009) ON THE ISSUANCE OF PRESIDENTIAL PROCLAMATION AND SPECIAL PATENT FOR SCHOOL SITES, PARTICULARLY NAPNAPAN ELEMENTARY SCHOOL, NAPNAPAN NATIONAL HIGH SCHOOL AND TIGBAUAN NATIONAL HIGH SCHOOL, ALL IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipal Mayor, Hon. James Excelsior M. Torres, this municipality, through his letter dated August 14, 2009, addressed to the SB Chair, Committee on Education, Health and Sanitation requested for an SB Resolution relative to the issuance of Presidential Proclamation and Special Patent for school sites, particularly Napnapan Elementary School, Napnapan National High School and Tigbauan National High School, in line with the DENR'S priority program for CY 2009;

WHEREAS, Napnapan Elementary School and Napnapan National High School, both located at Napnapan Sur, Tigbauan, Iloilo with an area of 1:0516 and 0.6000, respectively, had been identified by the DENR as potential areas based on the letter to Raymundo A. Lapating, Ph.D. CESO V, Schools Division Superintendent, DepEd, Division of Iloilo, La Paz, Iloilo City, dated 13 August 2009 by the OIC PENR Officer, Valentin P. Alabero;

WHEREAS, Mrs. Lira T. Cazeñas, Principal III, Tigbauan National High School, Tigbauan, Iloilo, in her letter dated August 19, 2009, requested to avail also of the DENR's priority program mentioned above;

WHEREAS, Tigbauan National High School is situated in the Poblacion, Municipality of Tigbauan, Iloilo;

WHEREAS, considering the importance of this program of the DENR to the benefit of the schools cited above, the Sangguniang Bayan strongly supports such project. It is urging for the compliance or submission of vital documents by the said schools to the DENR in order to have this project/program materialized leading to the issuance of Presidential Proclamation and Special Patent;

NOW, THEREFORE, on Motion of Hon. Suzette Marie Hilado-Banno, Chairman, Committee on Education, Health and Sanitation and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Norberto T.
