RESOLUTION IMPLEMENTING THE "ADOPT A MOJON" PROGRAM OF THE DENR UNDER THE PRS '92 PROGRAM FOR ALL SURVEYING AND MAPPING ACTIVITIES IN THE COUNTRY SPECIALLY AT THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, pursuant to Executive Order No. 45, Series of 1993, as amended by EO No. 280, series of 2000 and EO No. 321, Series of 2004, the Philippine Reference System of 1992 is the basic reference system for all surveying and mapping activities in the country;

WHEREAS, PRS '92 is a homogeneous national network of geodetic control points, physically marked by survey monuments or mojons;

WHEREAS, the DENR is currently undertaking survey and data integration activities nationwide to fast-track the implementation of PRS '92, and the DENR regional offices are the primary implementors of PRS '92 in the regions;

WHEREAS, the "Adopt-a-Mojon" Program of the DENR has the objective of enlisting the participation of the LGUs, the People's Organizations, and the general public in the establishment and preservation of the PRS '92 Geodetic Control Points (GCP) to service the geo-referencing needs of the surveying activities in the community at all times;

WHEREAS, the Local Government Offices/People's Organizations are the adopters of the nationwide network of Geodetic Control Points physically marked by the "mojons", owing to their capability and proximity to protect these GCPs from destruction, to maintain their physical condition, as well as to advocate their significance to land administration;

WHEREAS, the DENR regional offices and the local government offices/People's Organizations are partners to ensure the realization of a unified reference system for national development, with their partnership to be sealed through a Memorandum of Agreement and the specific conditions thereof stipulated in the attached Terms of Reference, with its annex containing the list of specific control points that will be adopted by the respective local government offices.

WHEREAS, for and in consideration of the above premises, the parties to this agreement do hereby mutually declare and agree as follows:

ARTICLE I

DUTIES AND RESPONSIBILITIES

The First Party shall:

- 1. Conduct periodic inventory and recovery of geodetic control points and other reference points;
- 2. Provide the official list, locations, and maps of geodetic control points for adoption;
- 3. Design the appropriate protection measures for the geodetic control points and supervise their construction;
- 4. Provide the guidelines for the protection and maintenance of the geodetic control points;
- 5. Extend technical assistance to the Secondary Party when necessary; and
- 6. Conduct an annual evaluation of this agreement.

The Second Party shall:

- 1. Assist in the periodic inventory and recovery of geodetic control points and other reference points;
- 2. Submit a report on the physical condition (i.e. disturbances or destruction) of the geodetic points and provide appropriate protection methods for them;
- 3. Protect and maintain the geodetic control points; and
- 4. Follow all guidelines in the implementation of the project.

ARTICLE II

EFFECTIVITY OF "ADOPT-A-MOJON"

The "Adopt-a-Mojon" program will take effect for a lifetime. At the end of each term of office of local government officials, newly elected officials should carry over the goals and objectives of the said program.

NOW, THEREFORE, on motion of Hon. Marlon R. Teruñez, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment & Expropriation and duly seconded by Hon. Suzette Marie Hilado-Banno, Hon. Suzette Tenefrancia-Alquisada, Hon. Agaton Tumabotabo, Hon. Norberto Turalba, Hon. Jose Tavarro, Jr, Hon. Loreta Lungay-Arias, Hon. Elmer Torrato, Hon. Orvillo Tangente and Hon. Lea Torreflores; be it,

RESOLVED, to implement the "Adopt A Mojon" Program Of The DENR Under The PRS '92 Program For All Surveying And Mapping Activities In The Country Specially At The Municipality Of Tigbauan, Province Of Iloilo, RESOLVED FINALLY, to furnish copies of this resolution to the Office of the Regional Executive Director, Office of the Municipal Mayor, Hon. James Excelsior M. Torres, and to all concerned for their information and/or appropriate action.
