## Resolution No. 2009-066

RESOLUTION AUTHORIZING HON. JAMES EXCELSIOR M. TORRES, MUNICIPAL MAYOR, TIGBAUAN, ILOILO TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE ILOILO PROVINCIAL GOVERNMENT IN ADOPTING A SEED ORCHARD ESTABLISHMENT IN MUNICIPAL GOVERNMENT PROPERTY AT BARANGAY SUPA, TIGBAUAN, ILOILO

WHEREAS, the Iloilo Provincial Government/PENRO under its Watershed Protection and Rehabilitation Project adopted a Seed Orchard Establishment in the identified municipalities of the Province;

WHEREAS, the said Project aims to help the municipalities, barangays and/or people's organization to substantially generate income derived from the products of the plantation;

WHEREAS, the project needs a Seed Production Area to sustain the supply of planting materials needed in the nursery operation, plantation establishment and in the maintenance activities;

WHEREAS, the Barangay Nutrition Committee, Municipality of Tigbauan and the Province of Iloilo, have manifested their desire to jointly implement this endeavor to further ensure the maintenance and protection of the area towards the abovementioned objectives;

WHEREAS, there is an imperative need to define the role of the Province, Municipality of Tigbauan and Barangay Supa Nutrition Committee which are indicated hereunder:

# A. Role of the Provincial Government

- 1. Delineate and prepare a development plan of the project showing the planting scheme, species and lay-out of the planting area;
- 2. Provide the needed number of fruit tree seedlings for the Communal Orchard establishment.
- 3. Provide technical and other forms of assistance deemed necessary to ensure success of the project;
- 4. Document, monitor and evaluate the project implementation;
- 5. Assist and/or identify and establish venue for marketing of products.

## **B.** Role of the Proponent Municipality

- 1. Provide manpower for the implementation of the project.
- 1. Provide at least one (1) hectare public land area located within the municipality for the establishment of the orchard;
- 2. Assist in the delineation of the planting area for orchard establishment, approximately 18% slope and above;
- 3. Enact Municipal Ordinance for the protection of the project implemented;
- 4. Oversee the harvesting and marketing scheme of the products derived from the plantation established.

## C. Role of the Assisting Barangay

- 1. Assist in the implementation of the project;
- 2. Assist in the delineation of the area for orchard establishment, approximately 18% slope and above;
- 3. Provide protection, care and maintenance of the seedlings planted;
- 4. Provide point person for coordination with the proponent Municipality.

## **OTHER PROVISIONS**

- 1. The sharing agreement of the proceeds derived from the products shall be on the following basis; 40% to the Provincial Government, 40% to the Municipality of Tigbauan as proponent and 20% to the assisting Barangay wherein the project was established. Further, the sharing of proceeds shall also be based on the number /amount of products derived from the plantation;
- 2. Management, control, maintenance and protection shall be under the jurisdiction of the proponent; and
- 3. Any matters necessary in or related to the project not specifically stated in this agreement shall be covered by an addendum agreement by both parties.

NOW, THEREFORE, on motion of HON. MARLON R. TERUÑEZ, Chairman, S.B. Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Suzette Marie Hilado-Banno, Hon. Suzette Tenefrancia-Alquisada, Hon. Agaton Tumabotabo, Hon. Norberto Turalba, Hon. Jose Tavarro, Jr., and Hon. Orvillo Tangente,

RESOLVED, to authorize Hon. James Excelsior M. Torres, Municipal Mayor, Tigbauan, Iloilo To Enter Into A Memorandum Of Agreement With The Iloilo Provincial Government In Adopting A Seed Orchard Establishment In Municipal Government Property At Barangay Supa, Tigbauan, Iloilo,
