RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-09-09-241 OF LUGEN ORTILANO ET-AL WITH TCT NO. T-183346, LOT NO. 1 WITH A TOTAL AREA OF 394 SQUARE METERS MORE OR LESS, CONTAINING TWO (2) LOTS LOCATED AT BRGY. ATABAYAN, TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application of LUGEN ORTILANO ET-AL with Subdivision Approval No. SA-09-09-241 with TCT No. T-183346, Lot No. 1 with an area of 394 square meters containing two (2) lots located at Brgy. Atabayan, Tigbauan, Iloilo with attached supporting documents was submitted by the Evaluating Officer to the Office of the Sangguniang Bayan, Tigbauan, Iloilo on September 10, 2009 for authorization and approval;

WHEREAS, the purpose/intent of this application is to subdivide among heirs/co-owners;

WHEREAS, the said land parcel was classified as built-up area in the zoning classification;

WHEREAS, the conditions of said approval shall be the following:

- a.) In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;
- b.) Comply with all the corrections as indicated on the plan;
- c.) Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.

BE IT RESOLVED, AS THIS SANGGUNIANG BAYAN HEREBY RESOLVED, to approve the Subdivision Application No. SA-09-09-241 of LUGEN ORTILANO ET-AL With TCT No. T-183346, Lot No. 1 With A Total Area Of 394 Square Meters More Or Less, Containing Two (2) Lots Located At Brgy. Atabayan, Tigbauan, Iloilo,
