RESOLUTION CONFORMING AND APPROVING THE BARANGAY SUPPLEMENTAL BUDGETS EMBODYING APPROPRIATION ORDINANCES OF THE FOLLOWING BARANGAYS: GENERAL FUND SUPPLEMENTAL BUDGET NO. 2009-001 OF BARANGAY #1 (POBLACION) FOR CY 2009, INVOLVING AN APPROPRIATION OF P111,344.80, APPROVED BY SANGGUNIANG BARANGAY ON OCTOBER 16, 2009 AND ENACTED UNDER APPROPRIATION ORDINANCE NO. 2009-002, GENERAL FUND SUPPLEMENTAL BUDGET NO. 2009-001 OF BARANGAY BUYU-AN FOR CY 2009, INVOLVING AN APPROPRIATION OF P204,229.60, APPROVED BY SANGGUNIANG BARANGAY ON NOVEMBER 2, 2009 AND ENACTED UNDER APPROPRIATION ORDINANCE NO. 2009-002, GENERAL FUND SUPPLEMENTAL BUDGET NO. 2009-01 OF BARANGAY #6 (POBLACION) FOR CY 2009, INVOLVING AN APPROPRIATION OF P101,301.45, APPROVED BY SANGGUNIANG BARANGAY ON NOVEMBER 4, 2009 AND ENACTED UNDER APPROPRIATION ORDINANCE NO. 2009-02, AND GENERAL FUND SUPPLEMENTAL BUDGET NO. 2009-001 OF BARANGAY BAGUINGIN FOR CY 2009, INVOLVING AN APPROPRIATION OF P188,248.45, APPROVED BY SANGGUNIANG BARANGAY ON OCTOBER 16, 2009 AND ENACTED UNDER APPROPRIATION ORDINANCE NO. 2009-002.

WHEREAS, the Municipal Budget Officer on November 11, 2009 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo the attached CY 2009 Barangay Supplemental Budget No. 2009-01 embodying Appropriation Ordinance No. 2009-02, of Barangay 1 (Poblacion), Barangay Buyu-an, Barangay 6, (Poblacion), Barangay Baguingin, this municipality;

WHEREAS, the Municipal Budget Officer has reviewed the CY 2009 Barangay Supplemental Budget of the afore-mentioned barangays involving the appropriation of P111,344.80, P204,229.60, P101,301.45, P188,248.45 and was approved by the Sangguniang Barangay on October 16, 2009, November 2, 2009, November 4, 2009, October 16, 2009 respectively, shows apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Appropriation Ordinances embodying the Supplemental Budgets for CY 2009 of the afore-mentioned barangays shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, the appropriation for the Supplemental Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government unit;
