RESOLUTION ADOPTING THE COASTAL RESOURCE MANAGEMENT OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Section 16 of the Philippine Fisheries Code of 1998 (RA 8550) states that the municipality shall have jurisdiction over municipal waters, thus shall be responsible for the management, conservation, development, protection, utilization and disposition of all fish and fisheries/aquatic resources within;

WHEREAS, an Executive Order No. 533 - "Adopting Integrated Coastal Management (AICM) as a National Strategy to ensure sustainable development of the country's coastal and marine environment and resources and establishing supporting mechanism for its implementation", was done in order to carry out the implementation of the Fishery Plans and Programs designed by the Local Government to improve productivity of marine resources and in order to create our own sources of revenues, consistent with the basic policy of local autonomy as mandated by RA 7160;

WHEREAS, on November 24, 2009, Hon. Mayor James Excelsior M. Torres, indorsed to the Hon. Members of the Sangguniang Bayan for their approval the Resolution Adopting the Coastal Resource Management Plan of the municipality;

WHEREAS, Chapter I of this Coastal Resource Management Plan pertains to the Introduction of the Scope, History of the Planning Process, Vision, Mission, Goals and Objectives;

WHEREAS, Chapter II pertains to the Coastal Environment Profile which relates the Historical Background, Geographical and Physical Setting; Status of Resources Population, Demography and Socio-Economics, Infrastructure, Agricultural & Fishery Services, Resource Uses and Institutional Development;

WHEREAS, Chapter III pertains to the Management Issues and Opportunities and among these issues and problems are: Socio-Economic and Livelihood, Waste Disposal, Resource Degradation and Administrative Issues;

WHEREAS, Chapter IV pertains to Coastal Management Programs, Strategies and Actions such as waste management, coastal tourism management, habitat management, coastal zoning, enterprise and livelihood development, fisheries development, legal arrangement and institutional development and shoreline development;

WHEREAS, Chapter V pertains to the administration and coordination of implementation, such as plan implementation, monitoring and evaluation, conclusion, recommendation, technical working group and committee to prepare CRM Plan;
