RESOLUTION REQUESTING THE HONORABLE MAYOR, JAMES EXCELSIOR M. TORRES TO RELIEVE MRS. LUZ TRONCO FROM PERFORMING OTHER FUNCTIONS SUCH AS PESO, BAC MEMBER, LIBRARIAN AND/OR RELIEVE HER OF HER CURRENT HRMO POSITION FOR REASONS THAT SHE IS INEFFICIENT IN THE PERFORMANCE OF HER JOB AND SHE COULD NOT DEFEND THE INTEREST OF HER MUNICIPALITY

WHEREAS, on November 11, 2009 a conference with Mrs. Luz Tronco together with the SB Members and the Vice Mayor was held by the Committee as a Whole in the SB Session Hall at 10:30 in the morning;

WHEREAS, Mrs. Luz Tronco responded to various questions and clarifications raised by the members of the committee regarding her functions, duties and other assignments;

WHEREAS, as a result of a lengthy discussion, it was found out from Mrs. Luz Tronco that her important functions as HRMO was neglected because she is performing too much extra work in the Municipal Government such as being a member in the BAC, as PESO Officer, as Librarian and above all, as an organizer and coordinator in the 1st Congressional District – CSC Sportsfest wherein she accepted that aside from the fact that she is not knowledgeable and competent on the rules of different games, she is also an ineffective coordinator of the said activity;

WHEREAS, that next time if ever there's still a Sportsfest Competition in the 1st Congressional District of Iloilo, we shall assign an organizer or coordinator who is competent, knowledgeable, and systematic in the scheduling of games, can defend our LGU during HRMO meetings and can make favorable decisions for the good and advantage of our municipality;

WHEREAS, a committee report (*attached as ANNEX "A"*) which is self-explanatory and forming an integral part of this Resolution was adopted by the August Body;

RESOLVED, to request the Honorable Mayor, James Excelsior M. Torres To Relieve Mrs. Luz Tronco From Performing Other Functions Such As PESO, BAC Member, Librarian And/Or Relieve Her Of Her Current HRMO Position For Reasons That She Is Inefficient In The Performance Of Her Job And She Could Not Defend The Interest Of Her **Municipality**,
