RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-111-09-243 OF SUSANA T. TINGALA, ET-AL WITH TCT NO. F-24936, LOT NO. 1645 WITH A TOTAL AREA OF 1,367 SQUARE METERS MORE OR LESS, CONTAINING THREE (3) LOTS LOCATED AT BRGY. BAGUMBAYAN, TIGBAUAN, ILOILO
