WHEREAS, the Municipal Budget Officer on November 25, 2009 and December 1, 2009 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2009 Barangay Supplemental Budgets embodying Appropriation Ordinances of the following Barangays: Isian, Napnapan Sur, Sipitan, Bayuco and Supa, this municipality;

WHEREAS, the Municipal Budget Officer has reviewed the said CY 2009 Barangay Supplemental Budgets involving the following appropriations: Brgy. isian – P106,466.85 (approved on November 28, 2009); Brgy. Napnapan Sur – P100,603.75 (approved on November 22, 2009) Brgy. Parara Sur– P153,299.20 (approved on November 8, 2009); Brgy. Sipitan – P79,763.75 (approved on November 21, 2009); Brgy. Bayuco – P77,526.50 (approved on November 16, 2009); Brgy. Supa - P81,371.00 (approved on December 6, 2009) and they show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing appropriation Ordinances embodying the Supplemental Budgets for CY 2009 of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, the appropriations for the Supplemental Budgets of the above-mentioned Barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government unit;
