RESOLUTION AUGMENTING THE TOTAL AMOUNT OF TWO MILLION FIVE HUNDRED FORTY-ONE THOUSAND SEVEN HUNDRED SIXTY PESOS (P2,541,760.00) FOR PAYMENT OF PRODUCTIVITY ENHANCEMENT INCENTIVE (PEI) FOR FISCAL YEAR 2009 AS PER BUDGET CIRCULAR NO. 2009-5 DATED DECEMBER 15, 2009 BY THE DBM AND REPRESENTATION & TRANSPORTATION ALLOWANCE (RATA) DIFFERENTIALS OF THE ELECTIVE MUNICIPAL OFFICIALS & DEPARTMENT HEADS EFFECTIVE APRIL 1, 2009 TO DECEMBER 31, 2009 PER LOCAL BUDGET CIRCULAR NO. 2009-91 DATED MARCH 27, 2009 BY DBM CHARGEABLE AGAINST PERSONAL SERVICES SAVINGS FOR CALENDAR YEAR 2009

WHEREAS, Budget Circular No. 2009-5 dated December 15, 2009 authorized the grant of Productivity Enhancement Incentive (PEI) to officials and employees of LGUs for fiscal year 2009;

WHEREAS, Local Budget Circular No. 2009-91 dated March 27, 2009 was issued to implement the Revised RATA rated for all local government officials and employees and to prescribe the funding source therefor, as authorized under Section 44, General Provisions of RA No. 9524 and FY 2009 General Appropriations Act (GAA), effective April 1, 2009;

WHEREAS, anent thereto, the Municipal Mayor, Honorable James Excelsior M. Torres, thru his letter dated December 16, 2009 to Hon. Suzette Marie Hilado-Banno, SB Chair, Committee on Appropriation, requested for the Sangguniang Bayan Resolution Augmenting the Amount of Two Million Five Hundred Forty-One Thousand Seven Hundred Sixty Pesos (P2,541,760.00) chargeable against Personal Services Savings for Calendar Year 2009 which will cover the RATA Differentials and Productivity Enhancement Incentive of every employee;

WHEREAS, the Member of the Local Finance Committee issued a certification that the amount of Two Million Five Hundred Forty-One Thousand Seven Hundred Sixty Pesos (P2,541,760.00) representing savings on the Personal Services for CY 2009 is available for payment of Productivity Enhancement Incentive (PEI) For Fiscal Year 2009 As Per Budget Circular No. 2009-5 Dated December 15, 2009 By The DBM And Representation &

Transportation Allowance (RATA) Differentials Of The Elective Municipal Officials & Department Heads Effective April 1, 2009 To December 31, 2009 Per Local Budget Circular No. 2009-91 Dated March 27, 2009 By DBM;
