RESOLUTION CONFORMING AND APPROVING THE BARANGAY SUPPLEMENTAL BUDGETS EMBODYING APPROPRIATION ORDINANCES OF THE FOLLOWING BARANGAYS: GENERAL FUND SUPPLEMENTAL BUDGET NO. 2009-01 OF BARANGAY **BUGASONGAN** FOR CY 2009, INVOLVING AN APPROPRIATION OF **P75,657.65**, APPROVED BY SANGGUNIANG BARANGAY ON NOVEMBER 22, 2009 AND ENACTED UNDER APPROPRIATION ORDINANCE NO. 2009-02; GENERAL FUND SUPPLEMENTAL BUDGET NO. 2009-001 OF BARANGAY **NAPNAPAN NORTE** FOR CY 2009, INVOLVING AN APPROPRIATION OF **P148,018.95**, APPROVED BY SANGGUNIANG BARANGAY ON NOVEMBER 28, 2009 AND ENACTED UNDER APPROPRIATION ORDINANCE NO. 2009-002; GENERAL FUND SUPPLEMENTAL BUDGET NO. 2009-01 OF BARANGAY **CANABUAN** FOR CY 2009, INVOLVING AN APPROPRIATION OF **P105,714.45** APPROVED BY SANGGUNIANG BARANGAY ON NOVEMBER 7, 2009 AND ENACTED UNDER APPROPRIATION ORDINANCE NO. 2009-002;

WHEREAS, the Municipal Budget Officer on November 25, 2009 and December 1, 2009 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2009 Barangay Supplemental Budgets embodying Appropriation Ordinances of the following Barangays: Bugasongan, Napnapan Norte, and Canabuan, this municipality;

WHEREAS, the Municipal Budget Officer has reviewed the said CY 2009 Barangay Supplemental Budgets involving the following appropriations: Brgy. Bugasongan – P75,657.65 (approved on November 22, 2009); Brgy. Napnapan Norte – P148,018.95 (approved on November 28, 2009) Brgy. Canabuan– P105,714.45 (approved on November 7, 2009);

WHEREAS, the Review of the foregoing appropriation Ordinances embodying the Supplemental Budgets for CY 2009 of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, the appropriations for the Supplemental Budgets of the above-mentioned Barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government unit;
