Resolution No. 2009-085

RESOLUTION AUTHORIZING THE RELEASE OF FUND FROM THE LOCAL 5% CALAMITY FUND TO DEFRAY EXPENSES FOR THE PROCUREMENT OF EQUIPMENT FOR DISASTER PREPAREDNESS IN THE AMOUNT OF ONE MILLION FOUR HUNDRED FOUR THOUSAND SEVEN HUNDRED EIGHTY PESOS (P1,404,780.00)

WHEREAS, the Philippine Archipelago is exposed to a lot of disasters whether of natural causes like floods, typhoons, volcanic eruptions, tidal waves or of man-made causes such as fire incidents, sea and air mishaps, insurgency, red tide, industrial pollution, technological hazards which contribute to the economic losses of the government and result into psychological trauma to the victims of the disaster who had lost member/s of their families, their livelihood and their properties;

WHEREAS, Presidential Decree 1566 was issued in 1978 by then President Ferdinand E. Marcos, June 11, 1978, strengthening the Philippine Disaster Control Capability and Establishing the National Program on Community Disaster Preparedness and local government units are mandated to provide thereon;

WHEREAS, Section 324 (d) of the Local Government Code of 1991 institutionalized the so-called local 5% Calamity Fund among local government units that was amended by Republic Act (RA) 8185;

WHEREAS, Joint Circular 2003-1 by the Department of Budget and Management and the Department of the Interior and Local Government was issued to clarify the utilization of the annual lump appropriations of local government units for relief, rehabilitation, reconstruction and other works or services in connection with calamities which may occur during the budget year as mandated under Section 324 (d) of RA 7160, otherwise known as the Local Government Code of 1991, as amended by RA No. 8185 with provisions that the appropriation may be validly used for relief, rehabilitation, reconstruction and works and services in connection with man-made disaster resulting from unlawful acts of insurgents, terrorists and other criminal as well as for disaster preparedness and other pre-disaster activities such as:

WHEREAS, the havoc brought about by Typhoon Frank last June 21, 2008 left us, first and foremost, the loss of lives of sixteen (16) Tigbauanons and millions of pesos in damages in infrastructure and agriculture;

WHEREAS, it is necessary that our LGU Tigbauan procure thee important equipments for disaster preparedness as soon as possible so that the tragedy during the Typhoon Frank must not happen to us again;

WHEREAS, the Local Government of Tigbauan through the Municipal Disaster Coordinating Council Chairman had in mind the procurement of Disaster Preparedness Equipments and proposed that it be made chargeable against the local 5% Calamity Fund or the total of 50% of the 5% in accordance with DBM-DILG Joint Circular 2003-1;

NOW, THEREFORE, on motion of HON. SUZETTE MARIE HILADO-BANNO, Chairperson, Committee on Appropriation, Budget, Finance, Accounts and Ways & Means and duly seconded by Hon. Agaton tumabotabo, Hon. Norberto Turalba, Hon. Jose Tavarro, Jr. and Hon. Loreta Lungay-Arias,

RESOLVED, to authorize the Release of Fund From The Local 5% Calamity Fund To Defray Expensed For The Procurement Of Equipment For Disaster Preparedness in the Amount Of One Million Four Hundred Four thousand Seven Hundred Eighty Pesos (P1,404,780.00),

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, and to all concerned for their information and/or appropriate action.
