Resolution No. 2010-001

RESOLUTION CONFORMING, APPROVING AND ADOPTING THE PRIORITIZED SOCIO-ECONOMIC DEVELOPMENT PROJECTS FROM THE CY 2010 20% INTERNAL REVENUE ALLOTMENT FUND (2010 ANNUAL DEVELOPMENT PLAN) OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipal Development Council of the Municipality of Tigbauan held a meeting on October 14, 2009, 10:00 o'clock in the morning at the Tigbauan Municipal Conference Hall to discuss the 20% Development Fund for the CY 2010. The Municipal IRA for CY 2010 is P62,387,618.00 and the Mandatory 20% IRA Development Fund for CY 2010 is P12,477,523.00. After a thorough deliberation and review of the prioritized projects, the Municipal Development Council approved the allocation of the 20% IRA Fund of the Local Government Unit of Tigbauan for the year 2010. The itemized projects and programs are enumerated in the Resolution of the Municipal Development Council hereto attached as Annex "A";

WHEREAS, the Office of the Municipal Mayor forwarded the Annual 20% Development Plan for CY 2010 to the Office of the S.B. on October 15, 2009;

WHEREAS, DOTS Budget of P80,000.00 was reduced to P50,000.00 and the remaining P30,000.00 was allocated for Bloodletting Program of the Municipal Health Unit;

WHEREAS, the budget allocation for Dental Program in the amount of P50,000.00 was added this year so that the Dental Department can function properly and can come up with free dental services for our indigent constituents;

WHEREAS, the *Community Development Assistance Program (CDAP)* in the amount of P2,000,000.00 under *SOCIAL SERVICES SECTOR* includes the Project Allocation of Vice Mayor, SB Members, SKMF President and Liga ng mga Barangay President for their respective proposed programs and projects;

WHEREAS, Mr. Jimmy Tupas, OIC-MPDO, announced that there has been a 20% IRA adjustment from CYs 2008 and 2009 amounting to P3,029,489.00 which was allocated for the Improvement and Rehabilitation/Construction of Municipal Roads and Bridges (Asphalting of Municipal Roads);

WHEREAS, Barangay Captains who were present aired out their respective barangay concerns and were acknowledged by the Hon. Mayor and he signified his assurance to give them special attention;

WHEREAS, the review of the foregoing Resolution of the Municipal Development Council embodying the 20% Development Projects for the year 2009, shows apparent compliance with Section 287 of the Local Government Code, Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, a Committee Report No. 2009-076 was adopted on December 23, 2009 and all the Findings will form part of this Resolution;

WHEREAS, the appropriation for the 20% Development Fund shall be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the 20% development fund shall be in accordance with Section 287 of the Local Government Code, Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001, Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government units;

NOW, THEREFORE, on motion of HON. SUZETTE MARIE HILADO-BANNO, Chairman, Committee on Appropriation, Budget, Finance, Accounts and Ways & Means and duly seconded by Hon. Agaton Tumabotabo, Hon. Marlon Teruñez, Hon. Norberto Turalba, Hon. Jose Tavarro, Jr., Hon. Loreta Lungay-Arias, Hon. Elmer Torrato and Hon. Orvillo Tangente,

RESOLVED, to conform, approve and adopt *the Prioritized Socio-Economic Development Projects From The CY 2010 20% Internal Revenue Allotment Fund (2010 Annual Development Plan) Of The Municipality Of Tigbauan, Province Of Iloilo,*
