Resolution No. 2010-007

RESOLUTION ENDORSING THE CHANGING OF THE NAME OF JAMOG ELEMENTARY SCHOOL TO PEDRO TEOLOGO MEMORIAL ELEMENTARY SCHOOL, TIGBAUAN, ILOILO

WHEREAS, the PTCA of Jamog Elementary School passed a Resolution requesting the Department of Education to change the name of Jamog Elementary School to Pedro Teologo Memorial Elementary School;

WHEREAS, Jamog Elementary School started in 1937 as Jamog Primary School, previously situated in the lot of Mr. and Mrs. Sabelo Yuro. In 1947, it got burned down so it was transferred to the lot where it presently stands, which is part of the property of the late Spouses, Pedro Tuburan Teologo and Marcelina Tumayao-Teologo;

WHEREAS, it was sometime in the 50's when the Local Government of Tigbauan was then looking for a place to construct a school house when the kind couple offered part of their property for the purpose;

WHEREAS, for one reason or the other, the Teologo properties were included and consolidated as part of the Zulueta properties, but said properties were foreclosed by the

Provincial Government of Iloilo for non-payment of taxes and in the government's proprietary capacity, the foreclosed properties of Zulueta became the Provincial Government Estate:

WHEREAS, in the early 70's after the declaration of the whole archipelago as Land Reform area, the Provincial Government Estate was covered by Operation Land Transfer, a program implemented by the Department of Agrarian Reform pursuant to P.D. No. 27, making the original small landowners as beneficiaries, giving them the chance to get back the land they originally owned;

WHEREAS, during the coverage of PD 27, the said school lot was placed under the name of the Municipality of Tigbauan which was the basis for the issuance of the tax declaration;

WHEREAS, due to the popular mandate of the local constituents who directly benefit from the school, a resolution was passed during the General PTCA Assembly Meeting last January 16, 2009 to change the name of the school to PEDRO TEOLOGO MEMORIAL ELEMENTARY SCHOOL;

WHEREAS, in recognition of the philanthropic deed of the late Teologo couple, a gesture of sincere gratitude must also be extended;

NOW, THEREFORE, on motion of Hon. Suzette Marie Hilado-Banno, Chairperson, Committee on Education, Health and Sanitation and duly seconded by Suzette Tenefrancia-Alquisada., Hon. Agaton Tumabotabo, Jose Tavarro, Jr., Hon. Loreta Lungay-Arias, and Hon. Elmer Torrato,

RESOLVED, to endorse the change of the name of Jamog Elementary School to Pedro Teologo Memorial Elementary School, Tigbauan, Iloilo,

RESOLVE FURTHER, to furnish copies of this resolution to Hon. Mayor James Excelsior M. Torres, to Department of Education (DepEd), District of Tigbauan, and to all concerned for their information and/or appropriate action.
