RESOLUTION AUTHORIZING HON. MAYOR JAMES EXCELSIOR M. TORRES TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) AND THE RELEASE OF THREE HUNDRED FIFTY SIX THOUSAND PESOS (PHP 356,000.00) CHARGEABLE AGAINST COMMUNITY DEVELOPMENT ASSISTANCE PROGRAM (CDAP) WHICH COMPRISED THE EQUIVALENT AMOUNT OF FORTY PERCENT (40%) AS COUNTERPART SHARE IN THE PROCUREMENT OF THE AMBULANCE UNIT, PAYMENT FOR THE THREE-YEAR LTO VEHICLE REGISTRATION AND THREE-YEAR GSIS COMPREHENSIVE INSURANCE

WHEREAS, the PCSO under the Office of the President was created principally to raise funds through lottery games to support the various healthcare programs, social and basic services of the government aimed at uplifting the quality of life of the Filipino people;

WHEREAS, the administration of President Gloria Macapagal-Arroyo (PGMA) through the PCSO, have been in the forefront of providing healthcare programs and social services, among others to millions of Filipinos nationwide;

Torres To Enter Into And Sign A Memorandum Of Agreement With The Philippine Charity Sweepstakes Office (PCSO) And The Release Of Three Hundred Fifty Six Thousand Pesos (Php 356,000.00) Chargeable Against Community Development Assistance Program (CDAP) Which Comprised The Equivalent Amount Of Forty Percent (40%) As Counterpart Share In The Procurement Of The Ambulance Unit, Payment For The Three-Year LTO Vehicle Registration And Three-Year GSIS Comprehensive Insurance,
