RESOLUTION AUTHORIZING HON. JAMES EXCELSIOR M. TORRES, MUNICIPAL MAYOR, TIGBAUAN, ILOILO, TO ENTER INTO A CONTRACT OF SALE WITH MS. LILIVER TUVILLARA RELATIVE TO THE PURCHASE OF A PARCEL OF LOT ATBARANGAY BAGACAY, TIGBAUAN, ILOILO

WHEREAS, the Extension Bagacay Secondary School started on June 16, 2009 in the area near the Bagacay Elementary School but was transferred to this lot, which will be purchased, on March 1, 2010 because the old site was prone to flooding;

WHEREAS, the parcel of lot with Lot No. 18526 with an area of 15,205 square meters located at Barangay Bagacay, Tigbauan, Iloilo is for sale in the amount of P500,000.00 at P32.89/square meter and is being owned by Ms. Liliver Tuvillara. All expenses which will be incurred during the sale shall be shouldered by the seller;

WHEREAS, the OPAPP and UNDP thru the AFP donated and built 2 school classrooms in the said lot. The Turn-Over Ceremony of the two buildings to Barangay Bagacay was held last February 26, 2010;

WHEREAS, it is important that the Municipality buys the said parcel of lot in order to satisfy the lot area requirement of the said school to the Department of Education before school opens in June 2010, otherwise, the school will be closed. Hopefully the school will stand on its own and become Bagacay National High School next school year if we can find funding for the old and new teachers;

WHEREAS, the P500,000.00 budget for the purchase of the parcel of land has been incorporated in the 20% IRA Allocation for Fiscal Year 2010;

NOW, THEREFORE, on motion of HON. SUZETTE MARIE HILADO-BANNO, Chairperson, SB Committee on Education, Health and Sanitation and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Agaton Tumabotabo, Hon. Marlon R. Teruñez, Hon. Norberto Turalba, Hon. Jose Tavarro, Jr., Hon. Loreta Lungay Arias, Hon. Orvillo Tangente and Hon. Lea Torreflores,

RESOLVED, to authorize Hon. James Excelsior M. Torres, Municipal Mayor, Tigbauan, Iloilo, to enter into a contract of sale with Ms. Liliver Tuvillara relative to the purchase of a parcel of lot at Barangay Bagacay, Tigbauan, Iloilo
