Resolution No. 2010-021

RESOLUTION AUTHORIZING HONORABLE JAMES EXCELSIOR M. TORRES, MUNICIPAL MAYOR, TIGBAUAN, ILOILO, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRARIAN REFORM REPRESENTED BY HON. NASSER C. PANGANDAMAN, SECRETARY FOR THE CONSTRUCTION/IMPROVEMENT/REHABILITATION OF FARM-TO-MARKET ROAD COVERING BARANGAY BUYU-AN-SUPA ROAD AND BARANGAY BANGKAL-OLO-BARROC ROAD IN THE AMOUNT OF FIVE MILLION PESOS (Php5,000,000.00).

WHEREAS, Mr. Wendell T. Tamorite, Senior Admin. Assistant II sent a letter to the Sangguniang Bayan, this municipality, dated March 19, 2010 requesting for the urgent passing of a “Resolution Authorizing Honorable James Excelsior M. Torres, Municipal Mayor, Tigbauan, Iloilo, To Enter Into A Memorandum Of Agreement (MOA) With The Department Of Agrarian Reform Represented By Hon. Nasser C. Pangandaman, Secretary For The Construction/Improvement/Rehabilitation of Farm-To-Market Road Covering Barangay Buyu-an-Supa Road And Barangay Bangkal-Olo-Barroc Road In The Amount Of Five Million (Php5,000,000.00)”;

WHEREAS, based on the said letter, the MOA is one of the requirements that the municipal government shall comply in order to implement this project thru administration;

WHEREAS, under the CY 2004 General Appropriations Act of GAA (R.A. No. 9206) nationally funded infrastructure projects may be implemented by Local Government Units with the demonstrated capability to undertake the project by themselves;

WHEREAS, the objective of this Agreement is to put in effect the collaborative effort among government agencies specifically the DAR and the LGU of Tigbauan in providing support services to the Agrarian Reform Communities and its adjoining areas;

WHEREAS, the DAR collaborates with local government units to assist in the implementation of support services such as infrastructure and agri-enterprise development projects;

WHEREAS, the LGU of Tigbauan signifies to be in-charge of implementing farm-to-market road projects in order to serve a greater number of its constituents;

WHEREAS, the LGU of Tigbauan shall be responsible for the maintenance of the road/s after its turn-over from the DAR, for the former to have a sense of ownership of this road project/s;

WHEREAS, in consideration of the foregoing premises, the parties to this MOA hereby agree to undertake the following:

- I. The DAR shall:
 - a. Provide the amount of Five Million Pesos (P5,000,000.00) for the Construction/improvement/rehabilitation of farm-to-market roads in Brgy. Buyuan-Supa Road (Sitio Barcelona), Brgy. Bangkal-Olo-Barroc Road, Tigbauan, Iloilo.
 - b. Upon signing of this Agreement, the DAR-Central Office shall download a mobilization fund amounting to 15% of the project fund and the subsequent release shall be based on the physical and financial report submitted by the LGU.
 - c. Monitor the participation of the agrarian reform beneficiaries in the implementation of the projects.
 - d. Monitor the implementation of the project by the LGU, through its Provincial Office, to ensure that the approved Program of Work (POW) is being followed in accordance with the Engineering standard and specification.
 - e. Secure necessary reports for consideration with the administrative report of the local DAR office concerned.
 - f. The DARPO shall submit to LGU an audited liquidation report equivalent to the 1.75% of the Total Project Cost released by the latter for the administrative and monitoring requirements of the DARPO for this project.
- II. The LGU shall:
 - a. Act as the administrator of the project by receiving the funds and oversee the implementation of the project based on the Program of Work/Financial Plan which forms part of this Memorandum of Agreement.
 - b. Prepare financial report based on existing accounting rules and procedures for the succeeding releases of funds.
 - c. Ensure that the proposed beneficiaries of the Project are among our CARP beneficiaries.
 - d. Ensure that in the implementation of the project, the beneficiaries of the Program, including the out-of-school youth, should be hired as laborer.
 - e. Consult the DAR in terms of the consistency of the identified project relative to the development plan of the ARCs and/or ARC Clusters.

- f. The LGU shall provide the DARPO with an equivalent amount of 1.75% of the Total Project Cost to cover for its administrative and monitoring requirements relative to project implementation.
- g. Lead the consultation meetings between and/or among stakeholders of the Project.
- h. Provide the DAR with necessary audited financial report as to the disbursement of funds and physical accomplishment of the Project being implemented.

NOW, THEREFORE on motion of HON. NORBERTO TURALBA, Chairman, S.B. Committee on Agriculture, Fisheries and Cooperatives and duly seconded by Hon. Suzette Marie Hilado-Banno, Hon. Agaton Tumabotabo, Hon. Marlon Teruñez, Hon. Jose Tavarro, Jr., Hon. Loreta Lungay-Arias and Hon. Lea Torreflores,

RESOLVED, to authorize Honorable James Excelsior M. Torres, Municipal Mayor, Tigbauan, Iloilo, To Enter Into A Memorandum Of Agreement (MOA) With The Department Of Agrarian Reform Represented By Hon. Nasser C. Pangandaman, Secretary For The Construction/Improvement-Rehabilitation of Farm-To-Market Road Covering Barangay Buyu-an-Supa Road And Barangay Bangkal-Olo-Barroc Road In The Amount Of Five Million Pesos (Php5,000,000.00).
