RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT (MOA) ENTERED INTO BY THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO REPRESENTED BY ITS MUNICIPAL MAYOR HONORABLE JAMES EXCELSIOR M. TORRES WITH THE DEPARTMENT OF AGRARIAN REFORM REPRESENTED BY ITS SECRETARY, HON. NASSER C. PANGANDAMAN, FOR THE CONSTRUCTION/IMPROVEMENT/REHABILITATION OF FARM-TO-MARKET ROAD COVERING BARANGAY BUYU-AN-SUPA ROAD AND BARANGAY BANGKAL-OLO-BARROC ROAD IN THE AMOUNT OF FIVE MILLION PESOS (Php5,000,000.00).

WHEREAS, Mr. Wendell T. Tamorite, Senior Admin. Assistant II sent a letter to the Sangguniang Bayan, this municipality, dated March 24, 2010 requesting for the urgent passing of a "Resolution Ratifying the Memorandum of Agreement Between LGU-Tigbauan and the Office of the Department of Agrarian Reform Represented by Hon. Nasser C. Pangandaman, Secretary;

WHEREAS, the Sangguniang Bayan has passed Resolution No. 2010-021 on March 24, 2010 authorizing Honorable James Excelsior M. Torres, Municipal Mayor, Tigbauan, Iloilo, To Enter Into A Memorandum Of Agreement (MOA) With The Department Of Agrarian Reform Represented By Hon. Nasser C. Pangandaman, Secretary For The

Construction/Improvement/Rehabilitation Of Farm-To-Market Road Covering Barangay Buyu-an-Supa Road And Barangay Bangkal-Olo-Barroc Road In The Amount Of Five Million Pesos (Php5,000,000.00), it, being one of the most important requirements relative thereto;
