RESOLUTION CONFIRMING AND APPROVING THE CY 2010 SUPPLEMENTAL BUDGET NO. 2010-01 EMBODYING APPROPRIATION ORDINANCE NO. 2010-02 OF BARANGAY NAMOCON, THIS MUNICIPALITY

WHEREAS, the Municipal Budget Officer on march 17, 2010 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2010 Barangay Supplemental Budget No. 2010-01 Embodying Appropriation Ordinance No. 2010-02 of Brgy. Namocon CY 2010 General Supplemental Budget No. 2010-01 Embodying An Appropriation Of 181,747.05, Approved By Sangguniang Barangay On March 1, 2010 And Enacted Under Appropriation ordinance No. 02;
