RESOLUTION CONFORMING AND APPROVING THE CY 2010 ANNUAL BUDGETS AND 20% DEVELOPMENT PLANS OF THE FOLLOWING BARANGAYS: BAGUMBAYAN, CORDOVA SUR, BUYU-AN AND BANTUD, THIS MUNICIPALITY

WHEREAS, the Municipal Budget Officer on April 7, 2010 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2010 Barangay Annual Budgets and 20% Barangay Development Plans of the following barangays:

- a.) Brgy. Bagumbayan CY 2010 General Annual Budget No. 2010-001 Involving An Appropriation Of P996,433.00, Approved By Sangguniang Barangay On January 20, 2010 And Enacted Under Appropriation Ordinance No. 01;
- b.) Brgy. Cordova Sur CY 2010 General Annual Budget No. 2010-001, Involving An Appropriation Of P873,514.00, Approved By Sangguniang Barangay On January 31, 2010 And Enacted Under Appropriation Ordinance No. 2010-01;
- c.) Brgy. Buyu-an CY 2010 General Annual Budget No. 2010-001 Involving An Appropriation Of P1,433,367.00, Approved By Sangguniang Barangay On February 7, 2010 And Enacted Under Appropriation Ordinance No. 01;

d.) Brgy. Bantud CY 2010 General Annual Budget No. 2010-001, Involving An Appropriation Of P665,213.00, Approved By Sangguniang Barangay On January 17, 2010 And Enacted Under Appropriation Ordinance No. 2010-01;

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Annual Budgets and 20% Development Plans which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Appropriation Ordinances embodying the Annual Budgets and 20% Development Plans for CY 2010 of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, the appropriations for the Annual Budgets and 20% Development Funds of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets and 20% Development Funds shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of Hon. Suzette Marie Hilado-Banno, and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Agaton Tumabotabo, Hon. Marlon Teruñez, Hon. Jose Tavarro, Jr., Hon. Loreta Lungay-Arias and Hon. Lea Torreflores,
