RESOLUTION FAVORABLY ENDORSING THE PROPOSED PROJECT OF THE NATIONAL GRID CORPORATION OF THE PHILIPPINES FOR THE CONSTRUCTION OF SOUTHERN PANAY BACKBONE TRANSMISSION PROJECT (SPBP) (138 KV COMPONENTS) PASSING/TRAVERSING THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the National Grid Corporation of the Philippines (NGCP) has officially taken over from the National Transmission Corporation (TransCo), the nationwide power transmission grid's operation, management and expansion;

WHEREAS, being the official holder of the franchise to operate and maintain the country's power transmission grid, the NGCP is proposing for the construction of the Southern Panay Backbone Transmission Project (138 KV COMPONENTS) to accommodate the load growth in the Panay Island and address low voltage problem thus, improving the transmission system's reliability and operational flexibility;

WHEREAS, the proposed *Southern Panay Backbone Transmission Project* will also make possible the extension of service to previously un-electrified areas in the island;

WHEREAS, anent thereto, a letter dated Dec. 7, 2009 was sent by Mr. Carmelino L. de Leon, *Head, Engineering Construction Department of the National Grid Corporation of the Philippines*, to the Hon. Mayor James Excelsior Torres of LGU-Tigbauan, requesting for the municipality's favorable endorsement of said proposed transmission line project which will pass/traverse the Municipality of Tigbauan;

WHEREAS, on June 1, 2010, the Hon. Mayor James Excelsior M. Torres referred the matter to the S.B. Chair on Energy for endorsement of the proposed project;

WHEREAS, after review and evaluation of the supporting documents, (such as the NGCP-PRIMER of the Southern Panay Backbone Transmission Project, the Barangay Bagumbayan Resolution No. 05 s. 2010 - "Resolution Endorsing The Construction Of Southern Panay Backbone Transmission Project Of The National Grid Corporation Of The Philippines (NGCP)", Mayor James Excelsior M. Torres favorable indorsement of said project dated May 17, 2010,... (etc.)), the August Body interposes no objection to the proposed project and considers the same as beneficial to the general public since it aims to improve the existing transmission system of the Panay island;
