WHEREAS, Mr. Victor Silla, Census Enumerator of Brgy. Turog-Turog, Oton, Iloilo included the following households namely: Mrs. Helen Cabalfin-(0012), Mr. Hilario Beloria-(0013), Mr. Rogelio Caballero-(0014), Mrs. Carmenia Antipatia-(0015), Mr. Herman Antipatia-(0016), Mr. Romeo Caballero-(0017), Mr. Lino Anarna-(0018), Mr. Federico Anarna, Sr.-(0019), Mr. Rolly Peñas-(0020), Mr. Samuel Fajutrao-(0021), Mr. Vicente Cabalfin-(0022), Mr. Ruben Alipan-(0023), Mr. Ricardo Peñas-(0024), Mr. Romeo Peñas-(0025), and Mr. Dionisio Peñas-(0026), and indicated that the above-mentioned households and the people living thereat as households and residents of Brgy. WHEREAS, the erroneous survey conducted by Census Enumerator of Turog-Turog, Oton, Iloilo is contradictory to the main objective of the National Census and Statistics Office in the conduct of 2010 Census of Households and Population and will greatly affect the census of the population and households of Barangay Sipitan and the Municipality of Tigbauan, in the Province of Iloilo;

WHEREAS, such erroneous survey of Census Enumerator of Barangay Turog-Turog, Oton will cause undue injury to Barangay Sipitan and the Municipality of Tigbauan, Province of Iloilo:

WHEREAS, the August Body of the Municipality of Tigbauan, together with the people of Barangay Sipitan vehemently object and condemn the acts of the Census
