**Resolution No. 2010-042**

RESOLUTION CONFORMING AND APPROVING THE CY 2010 SUPPLEMENTAL BUDGET EMBODYING APPROPRIATION ORDINANCE OF BARANGAY 6 (POBLACION), THIS MUNICIPALITY

WHEREAS, the Municipal Budget Officer on July 14, 2010, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached ***Supplemental Budget No. 2010-01 of Brgy. 6 (Poblacion) for CY 2010, involving an appropriation of P55,014.15, approved by the Sangguniang Barangay on June 23, 2010 and enacted under Appropriation Ordinance No. 2010-01;***

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Supplemental Budget which shows apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Supplemental Budget embodying Appropriation Ordinance for CY 2010 of the afore-mentioned barangay likewise shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, the appropriation for the Supplemental Budget of the above-mentioned barangay shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budget shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of Hon. Suzette Tenefrancia-Alquisada, Chairperson, Committee on Appropriation, Budget, Finance, Accounts and Legal Matters and duly seconded by Hon. Dennis Valencia, Hon. Agaton Tumabotabo, Hon. Elmer Torrato, Hon. Loreta Lungay-Arias, and Hon. Orvillo Tangente,

RESOLVED, to conform and approve the CY 2010 Supplemental Budget Embodying Appropriation Ordinance Of Barangay 6 (Poblacion), this Municipality,
