RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE ARTHUR DEFENSOR, SR., GOVERNOR OF THE PROVINCE OF ILOILO TO STATION BACK PROVINCIAL PAID MIDWIVES AND SANITARY INSPECTORS IN THE MUNICIPALITY OF TIGBAUAN WHO WERE PREVIOUSLY RECALLED BY THE PROVINCIAL GOVERNMENT DUE TO EXIGENCY OF SERVICE.

WHEREAS, it is one of the prime duties of the Local Government Unit to make health services accessible to the people;

WHEREAS, the Municipality of Tigbauan has a total population of 61,130 as of the latest census;

WHEREAS, the Rural Health Unit of the Municipality of Tigbauan who serves the populace has two (2) main health centers and eleven (11) barangay health stations;

WHEREAS, at present, the Rural Health Unit is being manned by two (2) Physicians, three (3) Nurses, thirteen(13) Midwives and three (3) Sanitary Inspectors;

WHEREAS, two (2) of the thirteen (13) Midwives and two (2) of the three (3) Sanitary Inspectors who are rendering their services in the municipality are provincial paid employees;

WHEREAS, two midwives and two sanitary inspectors who were provincial paid employees and who were previously stationed in the municipality of Tigbauan, were recalled by the Provincial Government last January 1, 2010;

WHEREAS, with the recall of provincial paid health providers, 20 barangays in the Municipality of Tigbauan has hampered health services;

WHEREAS, the services rendered by the said health personnel are essential in the meaningful, effective and efficient delivery of basic health services especially that they play vital roles in rendering service to the 52 barangays in the municipality;

WHEREAS, the Municipality is in dire need of their services due to the increasing and continuing demand for basic health services which may not be addressed effectively by the Municipality because the latter does not have sufficient fund to add more personnel to provide the same;

NOW, THEREFORE, on motion of Hon. Roel T. Jarina, M.D., Chairman, Committee on Health and Sanitation and duly seconded by Hon. Dennis Valencia, Hon. Agaton Tumabotabo, Hon. Elmer Torrato, Hon. Loreta Lungay-Arias, Hon. Orvillo Tangente and Hon. Lea Torreflores,

RESOLVED, to respectfully request the Honorable Arthur Defensor, Sr., Governor Of The Province Of Iloilo To Station Back Provincial Paid Midwives And Sanitary Inspectors In The Municipality Of Tigbauan Who Were Previously Recalled By The Provincial Government Due To Exigency Of Service,

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Arthur Defensor, Sr., and to all concerned for their proper information and guidance.
