**Resolution No. 2010-045**

RESOLUTION DESIGNATING HON. ROEL T. JARINA, MUNICIPAL VICE MAYOR, TIGBAUAN, ILOILO AND MR. EDWIN L. PIROTE, OIC, OFFICE OF THE MUNICIPAL TREASURER AS THE OFFICIAL SIGNATORIES IN ALL OFFICIAL TRANSACTIONS FOR ALL WARRANTS AND CHECKS DRAWN ON THE MUNICIPAL TREASURY FOR THE EXPENDITURES APPROPRIATED FOR THE OPERATION OF THE SANGGUNIANG BAYAN.

WHEREAS, Sec. 445 (a.1) of the Local Government Code of 1991 provides that “The Vice Mayor shall be the Presiding Officer of the Sangguniang Bayan and sign all warrants drawn on the municipal treasury for all expenditures appropriated for the operation of the Sangguniang Bayan”;

WHEREAS, in the exigency of public service and in order for the continuous and uninterrupted operations of the Office of the Sangguniang Bayan, it is imperative that the checks issued for the disbursement of funds for all expenditures appropriated for the operation of the Sangguniang Bayan be signed by the Municipal Vice Mayor as the counter-signatory with the Municipal Treasurer;
