Resolution No. 2010-047

RESOLUTION EXPRESSING SUPPORT TO RESOLUTION NO. 2010-084 OF THE SANGGUNIANG PANLALAWIGAN NG ILOILO.

WHEREAS, Resolution No. 2010-084 was passed by the Sangguniang Panlalawigan of Iloilo, denying the request of Hon. Ma. Aura Eugenia Landar-Layese to assume office as Ex-officio member of the Sangguniang Panlalawigan ng Iloilo effective July 1, 2010 in her capacity as the Interim President of the Philippine Councilor's League-Iloilo Chapter;

WHEREAS, the request of Hon. Ma. Aura Eugenia Landar-Layese was anchored on the following: authority to assume as the interim PCL Provincial Federation President which was issued by its national president and national chairman; opinion of the Iloilo Provincial Director of the department of Interior and Local Government in the interpretation of the PCL Constitution and by-laws; DILG Memorandum Circular No. 2004-083 relative to the status/term of office of PCL Ex-officio members of the Sangguniang Panlalawigan and the issue on deprivation of the PCL representation in the said August Body;

WHEREAS, said request was denied based on the following grounds:

- (1) Section 508 (b), Chapter II, Title VI of Republic Act 7160 otherwise known as the Local Government Code of 1991, to wit:

“That the Sanggunian Members of component cities and municipalities shall form a provincial federation and elect a board of directors and set of officers headed by the president. The duly elected president of the provincial federation of Sanggunian Members of the component cities and municipalities shall serve as such only during his term of office as president of the provincial federation of the Sanggunian Members of component cities and municipalities which in no case shall be beyond the term of office of the Sangguniang Panlalawigan concerned; (underlining and emphasis supplied)”;

- (2) Section 7 of Article XVII of the PCL Constitution and By-Laws (used as the basis for the DILG Memorandum Circular 2004-83 was superseded by 2007 Amended PCL Constitution and By laws which was ratified during the PCL 2007 National Assembly held at Cebu International Convention Center, Mandaue City, Cebu on March 8-10, 2007;

- (3) Section 6, Article XVI of the 2007 PCL Constitution and By-Laws which expressly provides that: “The term of office of all the officers in the League in all levels shall be the entire duration of their respective terms as councilor,” hence the term of office of the PCL Provincial Federation President elected in 2007 and serve as ex-officio member of the 9th Sanggunian expired on June 30, 2010

- (4) Section 509 of the Local Government Code of 1991 which provides that: “ Constitution and By-Law
