RESOLUTION REQUESTING HON. GOVERNOR ARTHUR D. DEFENSOR THROUGH DR. SILVINO R. TEODOCIO, JR. PROVINCIAL VETERINARIAN FOR ADDITIONAL ANTI-RABIES VACCINE TO BE USED BY THE MUNICIPALITY OF TIGBAUAN IN ITS CAMPAIGN AGAINST RABIES

WHEREAS, Tigbauan is the number three (3) Municipality in the Province of Iloilo affected by rabies;

WHEREAS, the Department of Agriculture has launched an anti-rabies vaccination campaign in all barangays of this municipality;

WHEREAS, as of July 31, 2010, less than fifty percent (50%) of the dog population has been vaccinated and immunized;

WHEREAS, in order to fully implement its anti-rabies campaign, the municipality needs more anti-rabies vaccines;

WHEREAS, the Provincial Veterinarian's Office has available anti-rabies vaccine;

WHEREAS, the Municipality of Tigbauan being the number three (3) most affected municipality, needs more anti-rabies vaccine;
