RESOLUTION TEMPORARILY SUSPENDING SECTION 8.2 “REGISTRATION FEE” OF MUNICIPAL ORDINANCE 2009-003 IN ORDER TO FULLY IMPLEMENT THE ANTI-RABIES VACCINATION IN THE MUNICIPALITY OF TIGBAUAN

WHEREAS, Rabies is a lethal disease contacted through dog bites;

WHEREAS, Region VI or Western Visayas is one of the regions greatly affected by rabies, and Tigbauan is one of the three (3) municipalities greatly affected;

WHEREAS, the Sangguniang Bayan, of the Municipality has approved a Municipal Ordinance No. 2009-003 – “The Rabies Control Ordinance of the Municipality of Tigbauan, Province of Iloilo” as guide in the implementation of its campaign against rabies;

WHEREAS, the Department of Agriculture as implementing agency, has launched a vaccination campaign, with over sixty (60) vaccinators covering fifty two (52) barangays;

WHEREAS, as of record, dog population is Nine Thousand Six Hundred (9,600), out of which only Four Thousand One Hundred (4,100) has been vaccinated

WHEREAS, the main reason for noncompliance of vaccination is the Registration Fee of One Hundred Pesos (P100.00), required for every dog prior to registration and vaccination;

WHEREAS, the Bill Gates Foundation through the World Health Organization (WHO) has donated anti-rabies vaccine to the Province of Iloilo;

WHEREAS, in order to fully implement our anti-rabies campaign, the Department of Agriculture of the Municipality has requested the Sangguniang Bayan to temporarily suspend payment of Registration Fee to accommodate dogs which were not registered;

NOW, THEREFORE, on motion of Hon. Alfonso Babiera, Chairperson, Committee on Agriculture, Fisheries and Cooperatives and duly seconded by Hon. Dennis Valencia, Hon. Agaton O. Tumabotabo, Hon. Loreta Lungay-Arias, Hon. Jose Donel Trasporto, Hon. Elmer Torrato, Hon. Marlon R. Teruñez, Hon. Orvillo Tangente and Hon. Lea Torreflores .

RESOLVE, AS IT IS HEREBY RESOLVED, to temporarily suspend Section 8.2 “Registration Fee” Of Municipal Ordinance 2009-003, in order to fully implement the anti-rabies vaccination in the Municipality Of Tigbauan,

RESOLVED FURTHER, to furnish copies of this Resolution to the Hon. Mayor James Excelsior M. Torres, and to all concerned for their information and/or appropriate action.
