RESOLUTION RESPECTFULLY ENDORSING TO DIRECTOR ARIEL VALENCIA REGIONAL DIRECTOR, DEPARTMENT OF HEALTH, REGIONAL OFFICE VI, MANDURIAO, ILOILO CITY, THE HEREIN PROJECT PROPOSAL FOR THE REHABILITATION OF PHASE 2 OF THE TIGBAUAN RURAL HEALTH UNIT.

WHEREAS, the Municipality of Tigbauan is a 2<sup>nd</sup> class municipality located in the Southern part of the Province of Iloilo;

WHEREAS, Municipality of Tigbauan has 52 barangays of which 9 barangays are located in the Poblacion;

WHEREAS, the Municipality of Tigbauan serves a total population of 61,130 as of the latest census;

WHEREAS, the Rural Health Unit of Tigbauan has a total of 13 Barangay Health Stations including 1 Main Health Center;

WHEREAS, the Municipality of Tigbauan had undergone the rehabilitation of Phase 1 of the Main Health Center last year which specifically aims to improve the delivery of health services in the municipality in the amount of Eight Million Pesos (P8M);

WHEREAS, the Municipality of Tigbauan lacks sufficient funds for the completion of the rehabilitation of Phase 2 of the Main Health Center in the amount of Nine Million Eight Hundred Five Thousand, Two Hundred Fifty and 25/100 (P9,805,250.25);

NOW, THEREFORE, on motion of HON. DENNIS VALENCIA, Vice Chairman, Committee on Health and Sanitation (under the Sponsorship of HON. VICE MAYOR ROEL T. JARINA, Chairman, Committee on Health and Sanitation) and duly seconded by Hon. Agaton Tumabotabo, Hon. Jose Donel T. Trasporto, Hon. Loreta Lungay-Arias, Hon. Marlon R. Teruñez and Hon. Lea Torreflores;

RESOLVED, to respectfully endorse to Director Ariel Valencia Regional Director, Department of Health, Regional Office VI, Mandurriao, Iloilo City, the herein project proposal for the rehabilitation of Phase 2 of the Tigbauan Rural Health Unit.
