RESOLUTION CONFORMING AND APPROVING THE CY 2010 SUPPLEMENTAL BUDGETS EMBODYING APPROPRIATION ORDINANCES OF THE FOLLOWING BARANGAYS: BAGUMBAYAN, DORONG-AN AND CORDOVA NORTE, THIS MUNICIPALITY

WHEREAS, the OIC, Municipal Budget Office on September 8, 2010, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2010 Supplemental Budgets Embodying Appropriation Ordinances of the following barangays:

Brgy. Bagumbayan General Fund Supplemental Budget No. 2010-001 for CY 2010, involving an appropriation of P56,198.90, approved by Sangguniang Barangay on September 5, 2010 and enacted under Appropriation Ordinance No. 20110-002.

Brgy. Dorong-an General Fund Supplemental Budget No. 2010-001 for CY 2010, involving an appropriation of P100,316.82, approved by Sangguniang Barangay on September 5, 2010 and enacted under Appropriation Ordinance No. 2010-002.

Brgy. Cordova Norte General Fund Supplemental Budget No. 2010-001 for CY 2010, involving an appropriation of P83,552.35, approved by Sangguniang Barangay on August 21, 2010 and enacted under Appropriation ordinance No. 2010-002.

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Supplemental budgets which shows apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Supplemental Budgets embodying Appropriation Ordinances for CY 2010 of the aforementioned barangay likewise shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) its Implementing Rules and Regulations, Executive Order No. 9 of President Gloria Macapagal Arroyo and dated 9 March 2001 and Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, the appropriation for the Supplemental Budgets of the above mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budget shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art 454 (d) Its Implementing Rules and Regulations, Executive Order No. 9 of President Gloria Macapagal Arroyo 9 March 2001 and Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;
