RESOLUTION REORGANIZING THE PEOPLE’S LAW ENFORCEMENT BOARD (PLEB) IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, as provided for by Sec. 43 of Republic Act 6975, the Sangguninag Panglungsod/Bayan in every city and municipality shall create such number of Peoples Law Enforcement board (PLEB). The PLEB shall have jurisdiction to hear and decide citizen’s complaint or cases filed before it against erring officers and members of the PNP;

WHEREAS, there is a need to reorganize the composition of the PLEB to foster efficient and effective public service;

WHEREAS, the PLEB shall be composed of the following:

1. Hon. Alfonso C. Babiera – Chairman, Committee on Peace & Order & Public Safety;
2. Hon. Orvillo T. Tangente – Presidnet, Liga ng mga Barangay;
3. Atty. Virgilio T. Teruel – Member of the BAR;
4. Ms. Gemma Mondragon – District Supervisor, DEPED; and

5. Mr. Wendell Tamorite- Private Secretary II
