RESOLUTION NO 2010-062B

RESOLUTION SUPPORTING AND RECOMMENDING THE SEPERATION OF TIGBAUAN NATIONAL HIGH SCHOOL-BAGACAY EXTENSION FROM TIGBAUAN NATIONAL HIGH SCHOOL, THEREBY CONVERTING IT TO BAGACAY NATIONAL HIGH SCHOOL

WHEREAS, Hon. Janette Loreto-Garin, M.D., representative in the 1st District of Iloilo authored a House Bill 1339 entitled: “An Act Separating The Tigbauan National High School-Bagacay Extension In Barangay Bagacay, Municipality Of Tigbauan, Province Of Iloilo, From The Tigbauan national High School converting It Into An Independent National high School To Be Known As Bagacay National High School and Appropriating Funds Therefore”;

WHEREAS, presently, the Bill is with the Committee on Basic Education and Culture in the house of the Representative;

WHEREAS, Hon. Janette L. Garin, Senior Deputy Majority Leader, a representative in the 1st District of Iloilo is of her great expectancy that the bill will be made into a law, provided that all the requirements be complied with;

WHEREAS, for the SY 2010-2011 – Bagacay Secondary School Extension population from 1st year to 4th year is 203. These students are coming from far-flung barangays namely, Buenavista, Guisian, Lanag, Danao, Cansilayan, Supa and Bugasongan which are recipients of the “KALAHI” Program;

WHEREAS, in order to advance the right of your youths in these areas to their secondary education, it is the duty of the local legislative unit to pass a resolution recommending the separation of Tigbauan National High School-Bagacay Extension from Tigbauan National High School, thereby Converting it to Bagacay National High School;

NOW, THEREFORE, on motion of HON. LORETA LUNGAY-ARIAS, Vice Chairman, SB Committee on Education and duty of the local legislative unit to pass a resolution recommending the separation of Tigbauan National High School-Bagacay Extension from Tigbauan National High School, thereby Converting it to Bagacay National High School;

RESOLVED, to support and recommend the Separation of Tigbauan National High School-Bagacay Extension From Tigbauan National High School, Thereby Converting It To Bagacay National High School,
