RESOLUTION NO. 2010-066

RESOLUTION FAVORABLY RECOMMENDING THE ACCREDITATION OF THE HEREIN ATTACHED LIST OF QUALIFIED NGOs, POs AND SIMILAR AGGRUPATIONS/GROUPS IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, pursuant to DILG Memorandum Circular No. 2010-73, the major activities and scheduling relative to accreditation and selection are indicated as follows:

Activity	Schedule
a. Inventory of Peoples, Non-Governmental Organizations or Business or Professional Groups	1 st Week of August
b. Call for Accreditation	2 nd Week of August
c. Accreditation Proper	3d Week of August
d. Selection of Representative to the Local Special Bodies	1-15 of September
e. Reconstitution and Convening of Local Special Bodies	3 rd Week of September

WHEREAS, this August Body has received said DILG Memorandum Circular last September 1, 22010 only;

WHEREAS, Non-Government Organization is an intermedian organization between the people and the state wherein the principal interest is to promote the welfare of the poor and disadvantaged. The members do not necessarily belong to such marginalized sector and live in the same community;

WHEREAS, people’s organization refers to an association of residents in a barangay or barangays. They are often formed among the disadvantaged sectors of society such as the farmer peasant, artisanal fisherfolks, workers in the formal sector and migrant workers, workers in the informal sector, indigenous peoples and cultural communities, women, youth and students, children, senior citizens, victims of calamities and disasters, differently abled persons, urban poor as defined under Republic Act No. 8425 or the Social Reform and Poverty Alleviation Act of 1997;

WHEREAS, accreditation is a continuing process wherein a people’s organization, non-government organization and business or professional group may apply and obtain accreditation at any time. The only legal effect of not applying for accreditation within the period prescribed by law and as reiterated in said DILG Memorandum Circular No. 2010-73, is that such organization is not entitled for representation in a local special body;

WHEREAS, the Committee received and reviewed the following qualified NGOs and Pos Board Resolution Authorizing the Board of Directors of their said Organization to be Accredited by the Sangguniang Bayan, Municipality of Tigbauan, Iloilo;

NOW, THEREFORE, on motion of Hon. Loreta Lungay-Arias, Chairman Committee on Indigents and NGOs and duly seconded by Hon. Jose Donel Trasporto, Hon. Elmer Torrato, Hon. Marlon terunez, Hon. Orvillo Tangente and Hon. Lea Torreflore,
