Resolution No. 2010-071

RESOLUTION AMENDING RULE VII, SECTION 7 AND RULE XVII OF RESOLUTION NO. 2010-038- “RESOLUTION APPROVING THE INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG BAYAN OF TIGBAUAN, ILOILO”.

WHEREAS, the newly elected Sangguniang Bayan members attended the training on effective local legislation sponsored by the Department of Interior and Local Government of Iloilo Province in cooperation with the League of Municipalities of the Philippines Iloilo Chapter on November 10-12, 2010 at Iloilo Grand Hotel;

WHEREAS, updates on certain rules and regulations affecting local legislation were tackled in the said training in order to enhance the skills of the Sanggunian Bayan members;

WHEREAS, certain practices of the Sanggunian should be corrected to cope with the recent developments;

WHEREAS, the following provisions of the Internal Rules of Procedure of the Sangguniang Bayan are amended to wit:

Section 7, Rule VII shall be amended to read:

“Any member of the Sanggunian who shall not be present after the Roll Call of the last member of the August Body shall be recorded as “LATE” and the time he/she arrives shall be recorded. A member is considered LATE if he/she arrives 15 minutes after the roll call. If he/she is on official business, he/she shall be marked as “O.B.” or on vacation leave or sick leave as the case maybe”.

A new section shall also be inserted as Section 5-A of Rule XVII, to read:

“Any member of the Sanggunian who arrives LATE as provided for under Section 7, Rule VII shall pay the penalty of One Hundred Pesos (P100.00)”.

NOW, THEREFORE, on motion of Hon. Jose Donel T. Trasporto, Chairman, Committee on Rules, Ordinances and Resolutions and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Loreta Lungay-Arias, Hon. Marlon Teruñez, Hon. Orvillo Tangente and Hon. Lea Torreflores;

RESOLVED, to amend Rule VII, Section 7 And Rule XVII of Resolution No.2010-038-“Resolution Approving The Internal Rules Of Procedure Of The Sangguniang Bayan Of Tigbauan, Iloilo”,

RESOLVED FURTHER, to furnish copies of this resolution to Hon. Mayor James Excelsior M. Torres and to all concerned for their information and guidance.
