WHEREAS, the Municipal Budget Officer on November 3, 2010 endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2010 Supplemental Budgets Embodying Appropriation Ordinances of the following barangays:

Barangay Taro General Fund Supplemental Budget No. 2010-001 for CY2010, involving an appropriation of P82,486.10, approved by Sangguniang Barangay on October 10, 2010 and enacted under Appropriation Ordinance No. 2010-002
